PLEASE NOTE. The following are transcriptions of various letters held in the East Sussex Record Office, in Lewes. East Sussex, under their reference number, P382/14/01, as given on the right, above. They have been reproduced here by kind pe4rmission of the Record Office and the present Hooe Parish Couincil.

General description:

This is all about the difficulties in obtaining a small piece of land on which to build a "Parish Room" for the villagers; eventually it was built and became the "Village Hall".

It comprises various official letters and agreements and small hand-written notes. At the time my grandfather was still head teacher at Hooe National School and the Clerk to the Parish Council was Richard W. Hayward.

The first letter is from the Heathfield Parish Council in reply to one sent to them by the Parish Council of Hooe. Heathfield had, obviously, sold a piece of parish property before and Hooe was asking advice on how to they should go about doing the same for the for their village's parish room.

[NOTE! Also included, in this documentation, is a 'Parish Property Fire Insurance' deed and an envelope, bearing the initials 'J. J. N, dated 1939, and marked "Clerk's Considered Statements Re: Parish Property" - unfortunately, the envelope is empty.]

Letter 01

This is a letter from Heathfield Parish Council to R. W. Hayward re their experience with the sale of Parish Council land. It is written on a small sheet of plain paper with a small fancy heading.

The Parish Council of Hooe having received an application to provide a site for the erection of a Parish Room for the purpose of recreation and reading, the applicants being desirous of obtaining for the purpose a plot of land being a portion of Parish Property vested in the Parish Council, containing about 24 poles, marked + in red ink on the Ordnance Map attached hereto.

It probably fell into the hands of the parish authorities prior to the passing of the Unions Act through its reputed owner becoming chargeable to the parish, it having evidently been originally an enclosure of road side waste.

Prior to the passing of the Local Government Act, 1894, the property was vested in the Overseers of the Poor & Churchwardens of the parish. The income of this and other parish property was, prior to the passing of the Act of 1894, and is still, applied to the relief of the Rates. The plot in question is let at 25/- per annum, equal to 1/7th of 1d in the £ on the Rateable Value of the Parish.

Article 2 of the Order directs that the purchase money shall be paid into the hands of the treasurer of the Parish Council and be placed by him to their credit, and under Article 3, the Parish Council are required to open a special account in their ledger and to credit that account with the amounts so paid.

Article 4 provides for the payment out of the purchase money of such expenses as are referred to in that Article, and with the exception of any payments made in that respect, the purchase money must remain in the Treasurer's hands to the credit of the Parish until an Order has been issued by the Board for its appropriation under Section 3 of the Statutes 5 and 6. Will. 4, cap 69.

Before any of the expenses are defrayed, the Bills of such expenses should be transmitted to the Board and the most convenient course will be for you to return to the Board, duly filled up and signed, the enclosed Form of Tabular Statement, accompanied by the Bills of Expenses.

With regard to the Conveyance of the property in question, I am directed to draw your attention to Section 14, Subsection (3) of the Statute 45 and 46, Vict, cap 58, and to state that it will not be necessary to submit the Draft of the Deed to the Board for approval, nor will it be requisite for you to forward the Deed for Sealing and Registration by the Board.
